

## **Code of Conduct**

### **Seventh Day Adventist Reform Movement Queensland Conference**

To ensure all visitors have a pleasant and safe weekend together at the QLD Conference Camp Meeting, the following code of conduct is to be upheld at all times throughout the camp.

The code of conduct and conditions of attendance of this church sponsored camp meeting are designed to provide an environment of both spiritual well-being and wholesome activities that can be both enjoyable and uplifting for all in attendance.

By attending and participating in the activities of this camp, you agree to abide by this code of conduct and understand that failure to do so will result in necessary action being taken by those in charge of camp order.

### **General Behaviour**

- All behaviour and conversation must be in line with Christian standards. Please keep in mind that we want to create a spiritual atmosphere where we can enjoy fellowship with each other and gain a blessing at the same time.
- Keeping in mind that this camp is designed to provide a spiritual blessing, attendance in all spiritual meetings is expected. Out of respect for the Lord and the speaker, please be on time for all meetings. Speakers will be encouraged to speak within their allotted time, allowing a sufficient break between each meeting. This will ensure the program runs smoothly and on time.
- In consideration of all guests staying on the camp grounds, all noise from camp attendees will be restricted between 10pm and 6am every night.

### **Dress Code**

#### *General*

- Please be prepared to uphold the standards of Christian modesty in your dress and deportment throughout the camp.
- All clothing for both genders must cover the shoulders at all times, no sleeveless tops or dresses are permitted. Please refrain from wearing tight-fitting clothing, or clothing with low neck-lines, whether you are male or female.
- Please do not wear clothing that reveals the midriff or any clothing that contains obscene or offensive prints or slogans.
- For all recreational activities, including water based, a sleeved shirt must be worn by all as a *minimum*.
  - For both males and females, shirts (or blouses respectively) must not have a revealingly low neck-line. They should cover the shoulders well and not reveal the midriff.
  - Life vests must be worn over the clothing of all participants anytime they are in a canoe
  - At no time will any inappropriate physical contact be permitted.
  - Anyone found to be in violation of these standards will be spoken to by a person in charge of camp order and asked to resolve the relevant issues.
  - If any person persists in violation of these standards, of which they have been notified, they will be asked to refrain from taking part in the relevant activity.

**Dress Code***Males*

- In view of maintaining a reverent atmosphere in meetings, all males are required to wear long pants or trousers. This includes for morning and evening worships.
- When wearing shorts at any other time, please ensure they are no shorter than 2-3 inches above the knee.

**Dress Code***Females*

- Please remember to wear a dress or skirt with hem well below the knee at all times throughout the camp. For recreational activities, culottes of modest length may be worn.
- Dresses and skirts should not be tight-fitting and must not be sleeveless nor have a revealingly low neck-line.
- If pants or shorts are to be worn for any reason, please wear them underneath a dress, skirt or culottes.

**Music Code**

- All music practices and presentations are to be sacred, uplifting and in accordance with the high Biblical standards of acceptable Christian music. Those appointed to the oversight of the music program will reserve the right to review all items to be presented in any programmed meeting.

**Camp Order & Safety**

- Camp order will be conducted by those outlined on the camp program, available upon arrival at the camp.
- In consideration for all, personal matters involving a male camp attendee will be dealt with by a male camp orderly, and personal matters involving a female camp attendee will be dealt with by a female camp orderly.
- Please respect the decisions made by those responsible for camp order. Under any circumstance where the code of conduct is made a matter of question, the person/s in charge of camp order will make the final decision.
- Parents are responsible for the safety and conduct of their children at all times. No youth/children are permitted on the camp grounds unless supervised by a parent or appointed adult guardian
